Aim of the Course

Syllabus

The course is split into eight modules

- Investigating accidents and incidents
- Measuring performance
- Protecting our environment

Duration

The course lasts for 4 full days, and can be run either as a block or spread over a period to suit your needs. A written assessment will be undertaken at the end of the course. There is also the requirement to complete a project in your workplace. This course can be undertaken at our training facility or, if there are sufficient candidate numbers, on your own premises.

Course Notes

Each candidate will be issued with extensive course notes, in the form of the IOSH course manual and workbook.

Who should attend

Line managers, supervisors, safety representatives, safety committee members and those with health & safety duties and responsibilities.

Qualification

On completion of the course assessment and workplace project, successful candidates will be awarded the IOSH Managing Safely Certificate.
